### LIST OF TRAINING SERVICE PROVIDERS PROGRAM YEAR 2023-2024

The Local Board of the Conexión Laboral Área Local Sur Central (CLAL Surcentral), invite universities and post-secondary educational entities, public and private, for profit or non profit, to submit their application to join the State List of Training Service Providers, corresponding to Program Year 2023-2024.


The training activities sponsored with funds from the Federal Law 113-129, of July 22, 2014, Workforce Innovation and Opportunity Act (WIOA), with the exception of Job Training and Custom Training, will be offered under the modality of Individual Training Accounts. They will be available to participants of the Programs for Adults and Dislocated Workers of the municipalities of Coamo, Juana Díaz, Salinas, Santa Isabel and Villalba, in order for them to be effectively integrated into the labor market.


Providers interested in belonging to the State List of Training Service Providers, both for Initial Eligibility and Continuous Eligibility, will request their inclusion through the ETPL module, which is found in the "Participant Record Information System" (PRIS). New providers who do not have a password to access the module must request it to the following email: [prisdddec@ddec.pr.gov](mailto:prisdddec@ddec.pr.gov).

All providers must guarantee the continuity of the service by offering the activity in its virtual modality, in case of interruptions or closures ordered by the government, for reasons of major cause.

Providers interested in belonging to the State List of Training Service Providers for the 2023-2024 program year, will have until **April 30, 2023** to complete their application through the ETPL electronic module.
